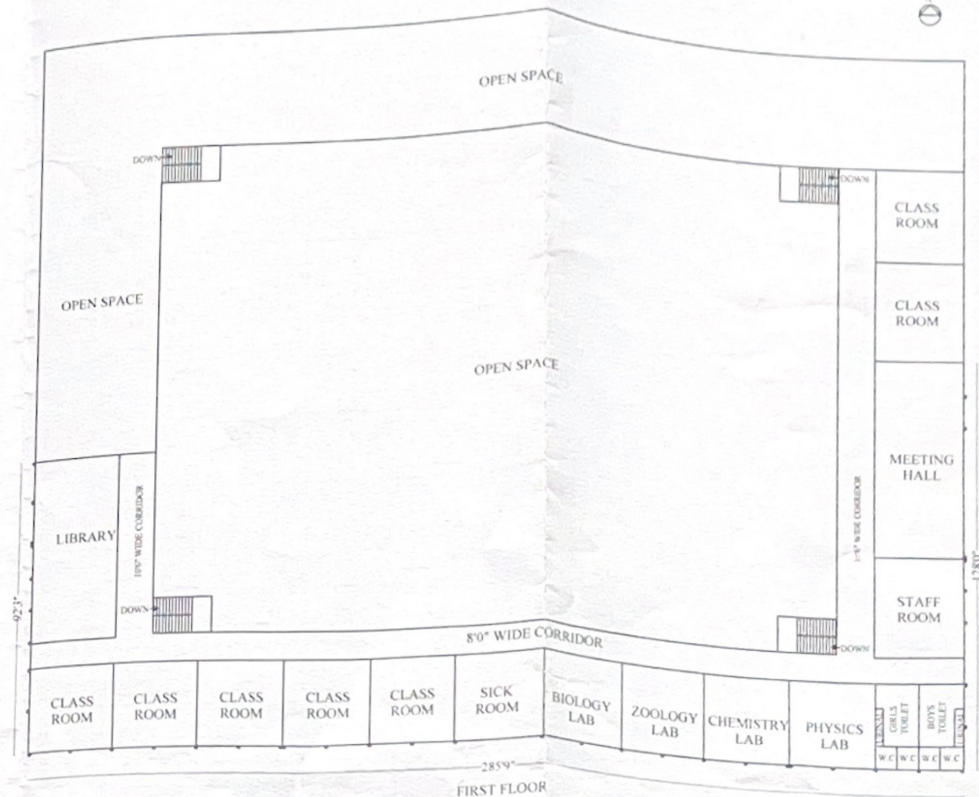
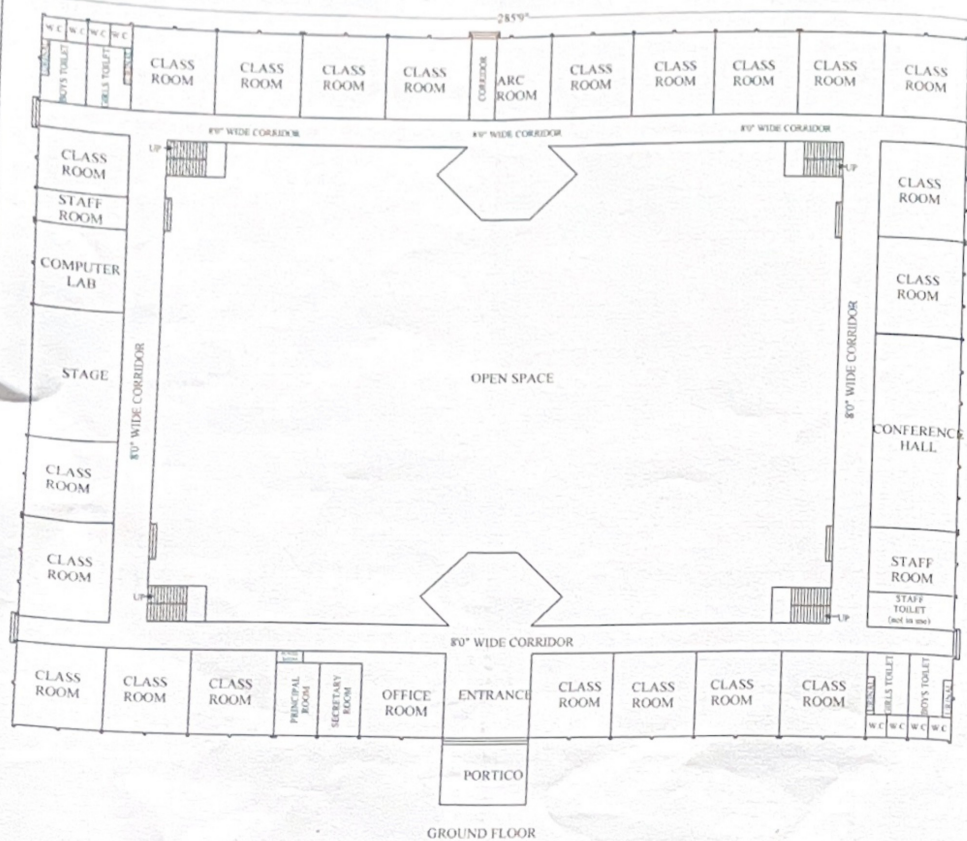

KEY PLAN OF S.B.K INTERNATIONAL SCHOOL, ARUPPUKOTTAI TOWN

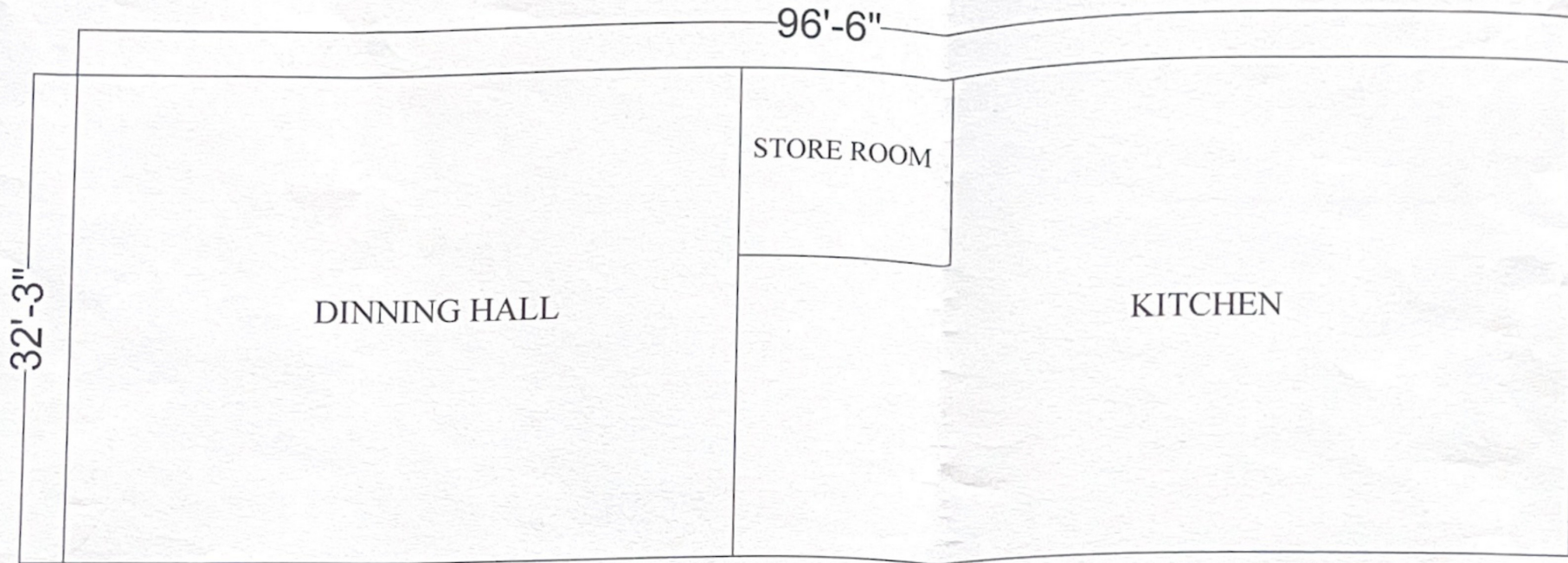

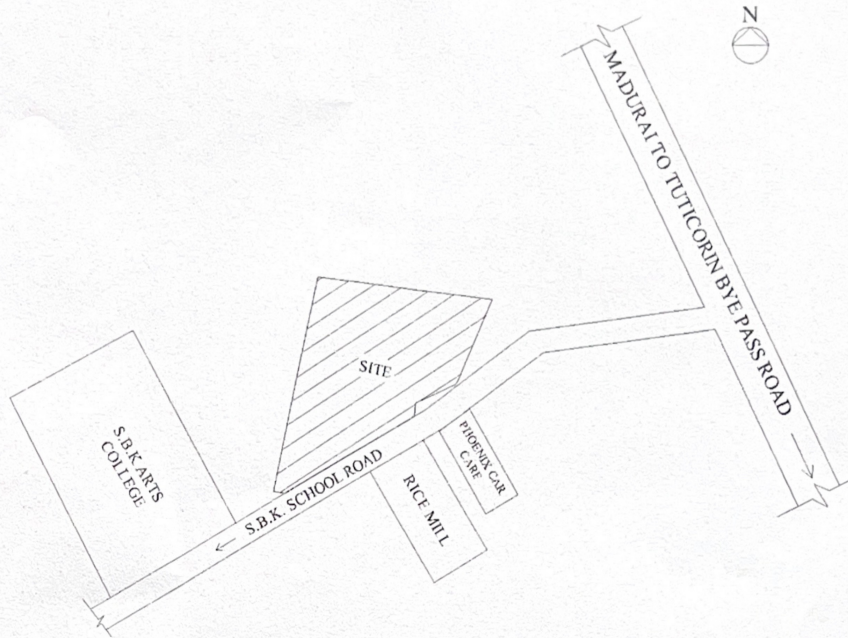
